DECLARATION OF CONFORMITY

Subject: Directive 2011/65/UE (RoHS 2)

Dear Customer.

Directive 2011/65 / EU (RoHS 2) sets forth norms regarding the restriction to use of hazardous substances (Annex II) in electrical and electronic equipment (EEE) in order to contribute to the protection of human health and the environment, including environmentally sound recovery and disposal of EEE waste. RoHS2 provides for CE marking on finished EEE and is no longer interconnected with the WEEE Directive. The scope of the directive is shown in Annex I:

Annex I Directive 2011/65 / EU (RoHS 2) - Categories of EEE regulated by RoHS 2

- 1. Large electrical household appliances
- 2. Small electrical household appliances
- 3. Computer and telecommunication equipment
- 4. Consumer equipment
- 5. Lighting equipment
- 6. Electrical and electronic tools
- 7. Toys and leisure and sports equipment
- 8. Medical devices
- 9. Monitoring and control tools, including industrial monitoring and control tools
- 10. Automatic dispensers
- 11. Other EEE not included in the above-mentioned categories

PA S.p.A. is a manufacturer of components and spare parts that function solely in a subordinate manner, connected to other machines and / or systems, the only ones that must be considered EEE.

The items of our production, which do not include components in brass (copper alloy), have a content of "restricted use" substances lower than the values prescribed in Annex II of the directive.

The items of our production, which include components in brass (copper alloy) are exempted as they are included in Annex III (applications exempt from restrictions) of the directive.
