RoHS Directive

The Directive 2011/65/EU (RoHS 2) establishes norms regarding the restriction to use dangerous substances (attached II) on electrical and electronic equipment (AEE), in order to contribute to the safety of human health and environment, including the salvage and correct ecological disposal of AEE waste.

In respect to RoHS 1 (Directive 2002/95/CE), RoHS 2 foresees the CE marking and presents itself as a special directive not interconnected to the Directive RAEE. In respect to the previous formulation, RAEE connections have been eliminated and respect the list of equipment included in the field of application with the attached I of the new directive. In connection, the field of application of the new directive is substantially amplified with the addition of a new category, which includes all the AEE not covered by any other of the 10 categories.
